The management company will assist the incubated companies in making an Accelerated Development Plan (ADP) for the initial two years, including strategic development, main tasks, budget plan and milestones, etc. Presently, the incubator has successfully introduced four Israeli companies: Changzhou Qualion NMR Systems Co., Ltd., Changzhou Syrolight Medical Devices Co., Ltd., Kencap Technology (Changzhou) Co., Ltd. and Biosep Medical Technology (Changzhou) Co., Ltd.
